Requirements...

Any contractor, service provider, material vendor, or other business entity may join. The BCCA will review applications and when approved add the company's contact information on our website listing page which is searchable by trade classification.

An applicant must provide at minimum proof of General Liability Insurance recognized by the State of Kentucky in the amount of \$100,000 coverage and add the BCCA as a Certificate Holder.

Companies with no employees may provide a Workman's Compensation waiver.

For Kentucky licensed trades, one should include their license numbers with application.



Public Listings...

Our goal is to provide a publicly available list of insured (and licensed as applicable) business contractors so anyone who requires total project management services to individual systems or property maintenance.

While the BCCA does not have any legal licensing authority, the public can be assured the list of businesses provided the minimum requirements of business operations. Most all our contractors are locally owned and operated with others from adjacent areas, all supporting our collective needs with integrity and competency.

Organizational Info...

The Barren County Contractors Association or BCCA is a non-profit, non-501c, LLC listed with the Kentucky Secretary of State. While the BCCA strived to maintain a close working relationship with local governments for the benefits to our members, the BCCA is a fully autonomous self-funding organization and not affiliated or otherwise supported by any city or county government or their funding.

Membership Fee...

Currently, the BCCA has three (3) levels of membership charged annually.

- General Contractor/Trade Specific \$125.00
- Vendor/Supplier/Businesses \$125.00
- Supporter/Provider for BCCA \$ Free

Exemptions...

Vendors, agencies, suppliers, and private persons (not engaged in contracting) in support of the BCCA and its goals are exempt from the insurance requirements.

Supporters or Providers of services for BCCA are provided a free membership voted by the Board for things like, but not limited to, meeting location, office supplies, or other operational needs as may arise.
